Page 25: Lawrie Metcalf was awarded the Veitch Memorial Medal in 1991, not 1995 as stated in Melanie Kinsey's article.

## Dawson, M. (2009). A history of *Leptospermum scoparium* in cultivation: Discoveries from the wild. *New Zealand Garden Journal 12*(2): 21–25.

Page 23: A cultivar selected by Graeme Platt and named after one of his daughters was referred to as *L*. 'Sherryl Lee'. Although this is how it is most commonly sold in the nursery industry, his daughters' first name is hyphenated and this should be followed in the cultivar name.

Page 5: For the reasons explained above, L. 'Sherryl Lee' should be hyphenated as L. 'Sherryl-Lee'.

## Dawson, M.; Hobbs, J.; Platt, G.; Rumbal, J. (2010). *Metrosideros* in cultivation: Pōhutukawa. *New Zealand Garden Journal 13(1)*: 10–22.

A plantsman of Gisborne was referred to as "Bob Bayly" (p. 15) and "Rob Bayly" (p. 17). This is the same person, the late Vale Rob Bayly, simply known as Rob Bayly. His name is correctly noted in *Commercial Horticulture*, Feb-March 2011 and in the *IPPS Newsletter*, Feb 2011, Vol. 42, Issue 1.

Page 18: The correct surname for the person who alerted Graeme Platt to *Metrosideros excelsa* 'Vibrance' is John Smith-Dodsworth (not John Dodsworth-Smith).

Images must be copyright free and if not the authors work, be fully credited to the original photographer or source and full permissions obtained. Images should be supplied ideally as high definition electronic copies, or as good quality photographs and slides. All original photographs and slides will be returned.
- Authors will receive two complimentary copies of the relevant journal issue on publication. Additional copies will be available at cost.
